

So what?

- Gives some indication that crime 'radiates' outwards from the most risky facilities
 - This can be used as leverage
 - (e.g. Clubs, large coffee chains and fast food chains need to get their houses in order) It does not just affect patrons but also passers by
 - It has planning implications
 - Mix different types of land-use
 - Do not place mega crime attractors/ generators next to each other
- Place management should go beyond the door








"Buy as much property around your rehabbed places as possible. Then you control the area"

What Was Jacobs Talking About?

- The importance of ownership
 - Foreshadowed Place Management (Eck, 1994)
 - The "A" component of ORCA (Madensen, 2007)
 - Property owners, real estate agents, bankers, governments, etc.
 - Have the authority to control



Jacobs on The Importance of Shopkeepers

"...storekeepers and other small businessmen are typically strong proponents of peace and order themselves; they hate broken windows and holdups; they hate having customers made nervous about safety. They are great street watchers and sidewalk guardians if present in sufficient numbers"

(Jacobs, 1961, p. 37)

Jacobs on The Importance of Shopkeepers

"...a network of doormen and superintendents, of delivery boys and nursemaids, a form of hired neighborhood, keeps residential Park Avenue supplied with eyes...[and]...if rents were to slip below the point where they could support a plentiful hired neighborhood of doormen and elevator men, it would undoubtedly become a woefully dangerous street"

(Jacobs, 1961, p. 40)

Jacobs on the Constant Succession of Eyes

There "...is a marvelous order for maintaining the safety of the streets...Its essence is intricacy of sidewalk use, bringing with it a constant succession of eyes...The ballet of the good city sidewalk never repeats itself from place to place..."






Key Points on Place Management






